## Coverage with you in mind

## Your Sientra Limited Warranty and Product Replacement Programs include:

- Up to \$3600 toward surgery, if needed due to a rupture within 10 years after your breast implant surgery
- Lifetime product replacement if your implant ruptures
- Free contralateral (opposite side) implant if needed

#### All Sientra implants are covered if they were implanted:

- According to the Sientra breast implant Directions for Use (www.sientra.com)
- By a board certified plastic surgeon
- In the United States after April 1, 2012

#### The Sientra Limited Warranty does NOT apply to the following:

- Adverse events other than rupture
- Rupture caused by surgical procedure or physical trauma
- Removal for capsular contracture\*
- Removal of implants to change the size or style of the implant

\* Capsular contracture is tightening of the scar tissue around an implant and can result in breasts becoming firm or hard.

### Easy to track, easy to enroll

#### Safety and simplicity in a single card

You are unique and so is your implant. Sientra is the only company in the United States that stamps each implant with a unique serial number. After your surgery, you will receive a Device Tracking and Sientra Warranty Card from your plastic surgeon. This card will list the serial number of your implant. Additionally, it will confirm your enrollment in the Device Tracking Program and in the Sientra Limited Warranty and Product Replacement Programs.

The C<sup>3</sup> Program

- Two-year coverage against capsular contracture starts the day of the primary augmentation surgery.
- Capsular contracture within that time means you get a replacement implant. Free.

Program Details:

- A diagnosis of Baker Grade III or IV capsular contracture is required to be eligible for the program.
- Replacement implant must be the same style as the primary augmentation implant, and the same size or one size up or down.
- C<sup>3</sup> provides the implant for free. It does not cover surgery or hospital costs.
- Replacement surgery must be by a board-certified or board-eligible plastic surgeon.

Important Safety Information

Sientra's Silicone Gel Breast Implants are indicated for breast augmentation in women at least 22 years old and for breast reconstruction. Breast augmentation includes primary breast augmentation to increase the breast size, as well as revision surgery to correct or improve the result of primary breast augmentation surgery. Breast reconstruction includes primary reconstruction to replace breast tissue that has been removed due to cancer or trauma or that has failed to develop properly due to a severe breast abnormality. Breast reconstruction also includes revision surgery to correct or improve the results of a primary breast reconstruction surgery.

Breast implant surgery is contraindicated in women with active infection anywhere in their bodies, with existing cancer or pre-cancer of their breast who have not received adequate treatment for those conditions and, who are pregnant or nursing.

Key complications include capsular contracture, implant removal, rupture and reoperation.
